

Access Award (Level 1)

How you'll be assessed

When studying an AAT qualification, your knowledge and skills will be tested via computer based assessments (CBAs). These are administered by assessment centres which are located throughout the UK, making it easy for you to take your exams.

Computer based assessments

Computer based assessments are marked one of three ways:

- wholly computer marked, and so results will be available automatically
- partially computer marked and partially human marked, and so results will be available within six weeks
- wholly human marked, and so results will be available within six weeks.

When are you assessed?

You will sit assessments when you are ready, along with the regular support via email, telephone and direct messaging you will have access to additional pre-examination support from the Student Support Team and Tutor Team to ensure you are fully prepared. The Student Support team will help you schedule your examinations.

Synoptic assessments will test your understanding of connections between the different topics covered across the qualification. Synoptic assessments are sat towards the end of a qualification and are taken at specific times of the year.
